CONSIDERING that pursuant to Rule 19(A) of the Rules, the President of the Tribunal shall coordinate the work of the Chambers;

CONSIDERING that pursuant to Rule 27(C) of the Rules, the President of the Tribunal may at any time temporarily assign a member of a Trial Chamber to another Chamber;

NOTING the composition of the Appeals Chamber of the Tribunal as set out in document IT/263/Rev.7, dated 16 December 2013;

NOTING the composition of the Trial Chambers of the Tribunal as set out in document IT/272, issued on 28 February 2011;

CONSIDERING the appeal management and case distribution needs of the Tribunal;

HEREBY ASSIGN, effectively immediately, Judge Bakone Justice Moloto to replace Judge Patrick Robinson on the Bench seised of the present case; and

HEREBY ORDER that the Bench in *Prosecutor v. Jadranko Prlić et al.*, Case No. IT-04-74-A, shall be composed as follows:


