**THIS TRIAL CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal");

**FURTHER CONSIDERING** that the portions specified in footnote 1 of the Order, corresponding to those identified by the Accused in the Request,<sup>3</sup> included the page range "T. 13130 ln. 25–T. 13031 ln. 16", which contains a typographical error, and should instead have read "T. 13130 ln. 25–T. 13131 ln. 16";

**ORDERS** that the following two corrections shall be made to the Order:
