74-T, by Trial Chamber III in French on 29 May 2013 ("Trial Judgement");

CONSIDERING that, pursuant to Rule 65 bis (B) of the Rules of Procedure and Evidence of the

Tribunal ("Rules") a status conference should be convened within one hundred and twenty days of

the filing of a notice of appeal and thereafter within one hundred and twenty days after the last

status conference, to allow any person in custody pending appeal the opportunity to raise issues in

relation thereto, including the mental and physical condition of that person;

NOTING that Jadranko Prlić, Bruno Stojić, Slobodan Praljak, Milivoj Petković, Valentin Ćorić,

and Berislav Pušić are currently in custody at the United Nations Detention Unit in The Hague

pending the resolution of the appeals filed against the Trial Judgement;

NOTING that the last status conference in this case was held on 21 January 2015;²
