**THIS TRIAL CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”);

**BEING SEISED OF** the Accused’s “Request for Reclassification”, filed confidentially on 3 September 2015 (“Request”) wherein the Accused requests that the Chamber order that its “Order Regarding Health of the Accused”, issued on 27 August 2015 (“Order”), and the “Deputy Registrar’s Submission in Compliance with the Order of 27 August 2015”, filed on 28 August 2015 (“Submission”) be reclassified as public;<sup>1</sup>

**NOTING** the Accused’s submission that while he appreciates the Chamber’s concern for his privacy, he wishes his case to be as public as possible;<sup>2</sup>

**NOTING** further that the Accused also requests that the Chamber order the reclassification of the Request, should it be granted;<sup>3</sup>

**NOTING** that the Office of the Prosecutor stated by way of email of 3 September 2015 that it did not wish to respond to the Request;

**CONSIDERING** further that it is in the interests of a public trial that the Order, the Submission, and the Request be made public;

**PURSUANT TO** Article 21(2) of the Statute of the Tribunal and Rule 54 of the Tribunal’s Rules of Procedure and Evidence,


