## ORDER REPLACING JUDGES TO A CASE BEFORE THE APPEALS CHAMBER

I, CARMEL AGIUS, President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal");

**NOTING** the "Decision on Prosecution Appeal Against the Decision on the Prosecution Motion to Revoke the Provisional Release of the Accused", rendered on 30 March 2015;

**NOTING** the "Urgent Prosecution Motion for Enforcement of Decision on Revocation of Provisional Release", filed on 14 April 2015;

**NOTING** the "Order Assigning Judges to a Case Before the Appeals Chamber", filed on 22 January 2015;

**NOTING** the "Order Replacing a Judge in a Case before the Appeals Chamber", filed on 14 April 2015;

**NOTING** that the terms of office of Judge Khalida Rachid Khan and Judge Bakhtiyar Tuzmukhamedov expired following the rendering of the Judgement in *Prosecutor v. Pauline Nyiramasuhuko et al.*, Case No. ICTR-98-42-A, on 14 December 2015 and the term of office of Judge Arlette Ramaroson expired following the rendering of the Judgement in *Prosecutor v. Stanišić and Simatović*, Case No. IT-03-69-A, on 15 December 2015;<sup>1</sup>

CONSIDERING Articles 12 and 14 of the Statute of the Tribunal;

**NOTING** that Rule 19(A) of the Rules authorises the President to coordinate the work of the Chambers;

**CONSIDERING** the composition of the Appeals Chamber of the Tribunal set out in document IT/263/Rev. 10, issued on 16 December 2015;

**CONSIDERING** the appeal management and case distribution needs of the Tribunal;
