

I, LEE G. MUTHOGA, Judge of the International Residual Mechanism for Criminal Tribunals ("Mechanism") and Single Judge in this case;<sup>1</sup>

BEING SEISED OF an application filed on 19 April 2016, in which Mr. Stanislav Galic seeks access to confidential *inter partes* material in the case of *Prosecutor v. Ratko Mladić*, Case No. IT-09-92-T ("Mladić case");<sup>2</sup>

NOTING the Prosecution's response filed on 29 April 2016;<sup>3</sup>

CONSIDERING Articles 1(1) and 5(1) of the Transitional Arrangements annexed to the Mechanism's Statute;<sup>4</sup>

CONSIDERING Rule 86(G)(i) of the Mechanism's Rules of Procedure and Evidence, which provides that a party to the second proceedings seeking to rescind, vary, or augment protective measures ordered in the first proceedings must apply to any Chamber, however, constituted, remaining seized of the first proceedings;

NOTING that Mr. Galic also filed the Application in the *Mladić* case, which are the first proceedings and currently pending before Trial Chamber I of the International Criminal Tribunal for the former Yugoslavia ("ICTY");<sup>5</sup>

FINDING that, in view of these circumstances, I lack jurisdiction over the Application;

FOR THE FOREGOING REASONS

HEREBY DISMISS the Application.
