Order to redact the public transcript
and the public broadcast of a hearing

The Trial Chamber

ORDERS that the following highlighted text (page 66, lines 17-18) be omitted from the public transcript of the hearing of and be edited from the public broadcast of this hearing of 16 August 2016.
