## REVISED ORDER IN LIEU OF INDICTMENT

**TRIAL CHAMBER I** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Chamber" and "Tribunal", respectively);

**NOTING** that on 30 October 2012, Trial Chamber II issued an order in lieu of indictment, charging, *inter alios*, Petar Jojić, Jovo Ostojić, and Vjerica Radeta ("Accused") with contempt of the Tribunal for having threatened, intimidated, offered bribes to, or otherwise interfered with witnesses in the cases of *Prosecutor v. Vojislav Šešelj* (IT-03-67-T and IT-03-67-R77.3);<sup>1</sup>

NOTING that on 5 December 2014, Trial Chamber II issued a revised order in lieu of indictment;<sup>2</sup>

**NOTING** that on 19 January 2015, Trial Chamber II, addressing the Republic of Serbia, issued warrants of arrest and orders for surrender in relation to the Accused;<sup>3</sup>

**NOTING** that on 7 April 2015, the President of the Tribunal assigned the instant case to the Chamber;<sup>4</sup>

**NOTING** that on 5 October 2016, the Chamber issued international warrants of arrest and orders for surrender in relation to the Accused;<sup>5</sup>

NOTING that on 16 March 2016, Interpol distributed Red Notices in relation to the Accused;<sup>6</sup>

**NOTING** that on 4 August 2017, the Registry submitted the official death certificate of Jovo Ostojić;<sup>7</sup>

**CONSIDERING** that in the case of the death of an accused, the proceedings against the deceased are to be terminated;

**PURSUANT TO** Rule 54 of the Tribunal's Rules of Procedure and Evidence;

VACATES the Tribunal's arrest warrants against Jovo Ostojić;

Public versions of these arrest warrants were subsequently issued.

ISSUES a revised order in lieu of indictment, set out in confidential and ex parte Annex A;

ISSUES a revised public redacted version of the operative order in lieu of indictment, set out in public Annex C; and

**ORDERS** the Registry to provide all United Nations member states and Interpol with this order and the revised redacted version of the operative order in lieu of indictment, set out in Annex B.
