**I, JUDGE ALPHONS ORIE**, Acting President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“Tribunal”);

**BEING SEISED** of the Deputy Registrar’s request filed on 4 September 2017 (“Request”) seeking an order for the reclassification as public of, *inter alia*, the Decision on Prlić’s Request for Review of the Registrar’s Decision on Remuneration for Additional Funds in Appeal Phase (“Decision”);<sup>1</sup>

**NOTING** that on 19 September 2017, the President of the Tribunal assigned me to consider the Request insofar as it relates to the Decision;<sup>2</sup>


**NOTING** the Registry’s submission that the Decision contains findings valuable to the jurisprudence of the Tribunal;

**CONSIDERING** that upon review of the Decision I have found no reason for it to remain confidential;

**CONSIDERING** that it is appropriate, however, to allow the Prosecution and the Prlić Defence an opportunity to make submissions in relation to any parts of the Decision that should remain confidential;

**HEREBY ORDER** the Registry to change the status of the Decision from confidential to public within two weeks from the date of this order, unless the Prosecution or the Prlić Defence file an objection within that period.
