TRIAL CHAMBER I of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“Chamber”);

NOTING its decision of 20 October 2017 (“Decision”), in which it dismissed the Defence’s urgent motion to compel the Registrar and United Nations Detention Unit staff to provide medical records of the Accused, filed on 27 September 2017 (“Motion”);¹


NOTING the Defence’s second additional submission filed on 20 October 2017, requesting binding orders to the Registry in relation to the provision of medical records and the scheduling of medical visits, as well as the initiation of contempt proceedings against Registry personnel (“Second Additional Submission”);²

CONSIDERING that the reasons for dismissing the Motion equally apply to the Second Additional Submission;

FOR THE SAME REASONS

DISMISSES the Second Additional Submission to the extent it is before the Chamber.
