I Honourable Justice Vivian M. SOLOMON, sitting as Designated Judge pursuant to the President's 'Order for Detention and Transfer and for Hearing pursuant to Article 12(F) of the Practice Direction on Conditional Early Release of Persons convicted by the Special Court for Sierra Leone':<sup>1</sup>

**RECALLING** the Disposition on the Matter of Moinina Fofana's Violations of the Terms of his Conditional Early Release ("Disposition"), filed on 26 April 2016;<sup>2</sup>

**NOTING** that the date in the last paragraph on page 2 was inadvertently stated to be "12 February 2015" instead of "10 February 2015;

**NOTING** that the dates in paragraph 8 on page 7 were inadvertently stated to be "22 October" 2016" and "23 October 2016", instead of "22 October 2015" and "23 October 2015";


**NOTING** that the first paragraph on page 20 and the second paragraph on page 23 are missing paragraph numbers and should read paragraphs 62 and 78, and that the respective subsequent paragraph numbers should be amended to read sequentially;

**NOTING** that the word "that" is duplicated in the last sentence of paragraph 36 and that the word "The" at the start of the third sentence in paragraph 43 is superfluous;

PURSUANT to Rule 54(B) of the Rules of Procedure and Evidence of the Residual Special Court for Sierra Leone;

ORDERS that the last paragraph on page 2 and paragraph 8 on page 7 of the Disposition be amended to reflect the correct dates of "10 February 2015" and "22 October 2015" and "23 October 2015" respectively; that the first paragraph on page 20 and second paragraph on page 23 be amended to read paragraphs 62 and 78 and that the respective subsequent paragraph numbers be amended to read sequentially; that the duplicated word "that" in the last sentence of paragraph 36, and the superfluous word "The" at the start of the third sentence in paragraph 43 be deleted, and that the amended Disposition be treated as authoritative.
