JUSTICE RENATE WINTER, PRESIDENT OF THE RESIDUAL SPECIAL COURT FOR SIERRA LEONE (“Residual Special Court”)

RECALLING the “Decision of the President on Application for Conditional Early Release” of 29 May 2017 (*RSCSL-04-14-ES-860*), in which it was ordered that Allieu Kondewa should continue to serve in prison custody a period of ten months from the date of that Decision to undergo specific training especially on human rights and correct behavior as a citizen of Sierra Leone, followed by certification of the training by the Registrar;

CONSIDERING that it was ordered that upon completion and certification of the training by the Registrar, the applicant may be released on execution of a Conditional Early Release Agreement in accordance with Article 9(C) of the Practice Direction on Conditional Early Release of Persons Convicted by the Special Court for Sierra Leone, and that the ten month period is normally ending on 29 March 2018;

SEIZED of a “Request for Extension of Time for Completion of Mr Kondewa’s Training” dated 13 March 2018, in which the Registrar is seeking an extension of the initial time limit of ten months by three months to complete the training, due to delays in completion of the last two modules of the training caused by Allieu Kondewa’s ill health;

SATISFIED that an extension of time is necessary to enable the Registrar to complete the required training and issue the proper certification;

GRANTS the request for extension of time by three months, and **ORDERS** that the Registrar shall complete the training and issue the proper certification not later than 29 June 2018.
