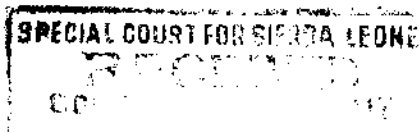

TRIAL CHAMBER II ("Trial Chamber") of the Special Court for Sierra Leone ("Special Court"), composed of Justice Richard Lussick, Presiding Judge, Justice Teresa Doherty and Justice Julia Sebutinde;

NOTING the "Decision on Prosecution Motion for Relief in Respect of Violations of the Trial Chamber's Decision of 9 May 2006", filed on 14 September 2006 ("the Decision");

NOTING THAT footnote 4 of the Decision read:

"The identifying data of DAB-025, DAB-023 and DBK-088 was disclosed on 21 July 2006 and they were called on 28 July 2006, 31 July 2006 and 1 August 2006 respectively; the identifying data of most witnesses called after the recess was only disclosed on 1 September 2006, i.e. DAB-018, DAB-043, DAB-115, DAB-114, DAB-092, DAB-040, DAB-039, DAB-107, DAB-113, DAB-084, DAB-129, DAB-130, DAB-135, DAB-131, DAB-128"

CONSIDERING THAT footnote 4 should read as follows:

"The identifying data of DAB-025, DAB-023 was disclosed on 21 July 2006 and they were called on 28 July 2006 and 31 July 2006 respectively; after the recess the identifying data of DAB-129, DAB-130, DAB-135, DAB-131 and DAB-128 was disclosed on 31 August and the witnesses were called in the period from 8 to 13 September 2006."

PURSUANT to Rule 54 of the Rules of Procedure and Evidence of the Special Court,

ORDERS that the Decision be amended as set out above.
