**TRIAL CHAMBER 1** ("The Chamber") of the Special Court for Sierra Leone ("Special Court") composed of Hon. Justice Bankole Thompson, Presiding Judge, Hon. Justice Pierre Boutet and Hon. Justice Benjamin Mutanga Itoe;

**SEIZED OF** the "Defence Request for Full Review of Prosecution Evidence to Identify Rule 68 Material for Disclosure", filed by Court Appointed Counsel for the Second Accused ("Counsel for Fofana") on the 24<sup>th</sup> of October 2006 ("Motion"),<sup>1</sup> wherein Counsel for Fofana request an Order from The Chamber to the Prosecution to review all material in their possession for potential Rule 68 material;<sup>2</sup>

**CONSIDERING** that the Defence case for all Accused persons was closed on the 18<sup>th</sup> of October 2006<sup>3</sup> and that no further evidence will be called in this case;<sup>4</sup>

**CONSIDERING** that Article 17(4)(c) of the Statute of the Special Court provides that the Accused shall be "tried without undue delay";


**CONSIDERING** that the fair and expeditious consideration of the Motion requires the imposition of an expedited timetable for the filing of any remaining written submissions;<sup>5</sup>


**PURSUANT** to Rule 7(C), 26bis, 54 and 73 of the Rules of Procedure and Evidence of the Special Court;


**HEREBY ORDERS** as follows:
