NOTING the "Decision on Urgent Prosecution Motion for Immediate Protective Measures for Witnesses and for Non-Public Disclosure", dated 15 September 2006 ("the Decision");

NOTING THAT the preamble of the Decision should read as follows:

"ORDERS that the protective measures ordered in the Trial Chamber's "Decision on Confidential Prosecution Motion for Immediate Protective Measures for Witnesses and for Non-Public Disclosure and Urgent Request for Interim Measures <u>and</u> on Confidential Prosecution Motion for Leave to Substitute a Corrected and Supplemented List as Annex A of the Confidential Prosecution Motion for Immediate Protective Measures for Witnesses and for Non-Public Disclosure and Urgent Request for Interim Measures" dated 5 May 2006 shall also apply to the witnesses referred to in Annex A of the Motion";

ORDERS that the Decision be amended as set out above.
