MINDFUL of the “Oral Decision on Defence Motions for Judgement of Acquittal Pursuant to Rule 98”, delivered on the 25th of October, 2006;

HAVING RECEIVED the “Sesay Defence Request for Clarification on Rule 98 Decision”, filed by Counsel for the First Accused, Issa Hassan Sesay, (“Defence”) on the 7th of November, 2006 (“Motion”);
