SEISED of the Urgent and Public Joint Submission by the Office of the Principal Defender and the Prosecution in Relation to the Re-Commencement of the Trial on 3 July 2007, filed 28 June 2007 ("Joint Motion"), wherein the Prosecution and Duty Counsel for Charles Taylor request in the interests of justice, a postponement of the resumption of the Prosecution case until 20 August 2007;

RECALLING the Trial Chamber's oral Order of 25 June 2007 that the Prosecution's case continues from 3 July 2007 to 11 July 2007;¹

SATISFIED that the Parties have shown good cause and that it would be in the interest of justice to modify the trial schedule and postpone the trial until 20 August 2007;

CONSIDERING that it would be in the interests of a fair and expeditious trial for the Trial Chamber to expedite its decision on the Joint Motion and to give its reasons in open court on 3 July 2007 at 9:00 a.m.;

GRANTS the Joint Motion and ORDERS

- (i) That the Court will reconvene on 3 July 2007 at 9:00 a.m. in order for the Trial Chamber to deliver its reasons for this decision;
- (ii) That the continuation of the Prosecution Case is postponed until 20 August 2007 at 9.00 a.m.
