**RECALLING** that this case opened on the 3<sup>rd</sup> of June 2004, and closed on the 18<sup>th</sup> of October 2006;




**RECALLING** that the closing arguments of the parties were heard between the 28<sup>th</sup> November and the 30<sup>th</sup> of November 2006;


