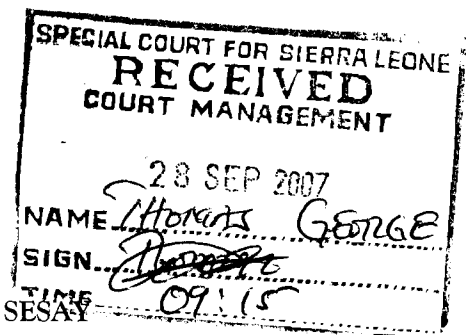

**TRIAL CHAMBER I** ("Trial Chamber") of the Special Court for Sierra Leone ("Special Court") composed of Hon. Justice Benjamin Mutanga Itoe, Presiding Judge, Hon. Justice Bankole Thompson, and Hon. Justice Pierre Boutet;

**NOTING** the Motion Requesting Reasons for Prosecution Objection to Authenticity of the Exhibits Filed by Issa Sesay, filed publicly by the Defence for the First Accused, Issa Hassan Sesay ("Sesay Defence") on the 30<sup>th</sup> of April 2007 ("Motion") requesting that the Office of the Prosecutor ("Prosecution") provide a reasoned explanation for its objection to each and all Sesay Defence exhibits as indicated in its Exhibits Chart on the grounds of lack of authenticity;<sup>1</sup>

**NOTING** the Response to the said Motion filed by the Prosecution on the 8<sup>th</sup> of May 2007 ("Response");

**NOTING** that the Sesay Defence did not file any Reply to the Prosecution Response;

**REITERATING** that, the parties cannot without leave of the Trial Chamber withdraw a Motion after it has been filed;<sup>2</sup>

**NOTING** that during the Status Conference held in this case on the 26<sup>th</sup> of September 2007, the Sesay Defence indicated its intention to withdraw the Motion on the basis of the Prosecution Response thereto;<sup>3</sup>

**CONSIDERING** the reasons outlined by the Sesay Defence at the said Status Conference for its withdrawal of the Motion;<sup>4</sup>




GRANTS leave to the Sesay Defence to withdraw the said Motion. The Motion is accordingly struck out.

INSTRUCTS Court Management Section to strike out the Motion from the Record.


