## ORDER RE-SCHEDULING SENTENCING JUDGEMENT



**TRIAL CHAMBER I** ("Trial Chamber") of the Special Court for Sierra Leone ("Special Court") composed of Hon. Justice Benjamin Mutanga Itoe, Presiding Judge, Hon. Justice Bankole Thompson, and Hon. Justice Pierre Boutet;

**NOTING** the Judgement rendered against the Second Accused, Moinina Fofana ("Fofana") and the Third Accused, Allieu Kondewa ("Kondewa") on the  $2^{nd}$  of August 2007, where the Trial Chamber found Fofana guilty on Counts 2, 4, 5 and 7 and Kondewa guilty on Counts 2, 4, 5, 7 and 8 of the Indictment;

**NOTING** the Scheduling Order for Sentencing Hearing and Judgement issued on the  $2^{nd}$  of August 2007, ordering that the Sentencing Judgement would be rendered on the  $24^{th}$  of September 2007;

**NOTING** the Sentencing Hearing held pursuant to Rule 100(B) on the 19<sup>th</sup> of September 2007;

**NOTING** that at the Sentencing Hearing, the Chamber ordered that the Sentencing Judgement would be rescheduled to the 1<sup>st</sup> of October 2007;

**NOTING** the Order Re-Scheduling Sentencing Judgement filed on the  $28^{th}$  of September 2007, rescheduling the Sentencing Judgement to the  $8^{th}$  of October 2007;

SEIZED of the Request for Modification of Scheduling Order filed by the Defence for the Second Accused, Moinina Fofana, on the 28<sup>th</sup> of September 2007, requesting that the Scheduling Judgement be held on the 9<sup>th</sup> of October 2007 in order to accommodate prior commitments of international Defence Counsel;

**CONSIDERING** that the Chamber finds that it is in the interests of justice to grant this request;
