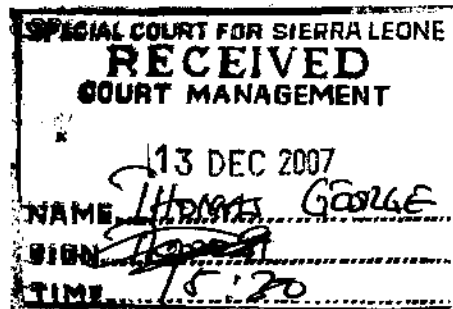

The Appeals Chamber,

SEISED of the Joint Prosecution and Defence Request for an Order for Expedited Filing ("Joint Motion"), filed on 7 December 2007, which requests
