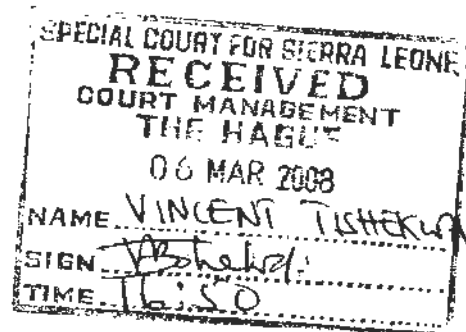

SEISED of the "Public Urgent Defence Motion Regarding a Fatal Defect in the Prosecution's Second Amended Indictment Relating to the Pleading of JCE", filed on 14 December 2007, ("Motion");<sup>1</sup>


HEREBY ORDERS that:
