

TRIAL CHAMBER II ("Trial Chamber") of the Special Court for Sierra Leone ("Special Court");

SEISED of the "Public Urgent Defence Motion Regarding a Fatal Defect in the Prosecution's Second Amended Indictment Relating to the Pleading of JCE", filed on 14 December 2007, ("Motion");

NOTING the Prosecutions submissions in response² and the Defence submissions in reply;³

NOTING the recent Appeals Chamber Judgement in the case of the *Prosecutor v. Brima, Kamara, Kanu* (SCSL-04-16-A), dated 22 February 2008 ("AFRC Appeal Judgement")⁴, in which findings were made that may have a bearing on issues raised in the Motion;

CONSIDERING that the submissions of the Parties in the Motion, Response and Reply predate the AFRC Appeal Judgement and that the Parties may therefore wish to reconsider their submissions on this issue;

HEREBY ORDERS that:

- (i) The Defence file a consequential submission, if any, by 4:00 pm on Monday, 31 March 2008;
- (ii) The Prosecution file a Response thereto, if any, by 4:00 pm on Thursday, 10 April 2008;
- (iii) The Defence file a Reply, if any, by 4:00 pm on Tuesday, 15 April 2008;
