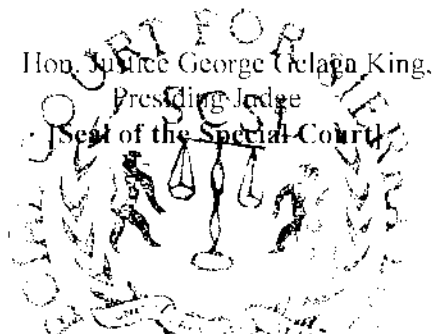
NOTING the "Prosecution's Reply Brief" and "Allieu Kondewa's Reply Brief" filed on 28 January 2008;⁴
