"TRIAL CHAMBER II ("Trial Chamber") of the Special Court for Sierra Leone ("Special Court");

SEISED OF the "Urgent and Confidential with Confidential Annexes A, B, C and D Defence Motion Pursuant to Rule 75(G) to Rescind Closed Session Protective Measures Granted Orally in Other Proceedings for Witness TF1-168", filed on 9 June 2008 ("Motion"),¹ wherein the Defence requests the rescission of the protective measure of closed session previously granted to Witness TF1-168 pursuant to Rule 75(B)(ii) of the Rules of Procedure and Evidence ("Rules");

NOTING that Witness TF1-168 is scheduled to testify in the week of 16-20 June 2008;²

CONSIDERING THEREFORE that an urgent resolution of this matter is in the interests of justice;
