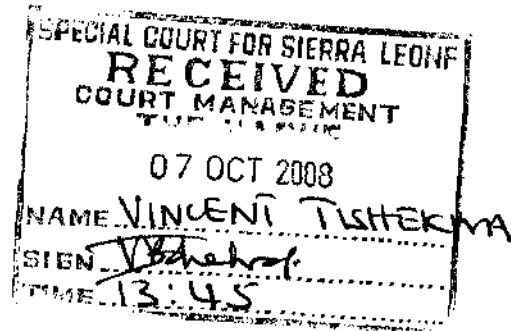

TRIAL CHAMBER II ("Trial Chamber") of the Special Court for Sierra Leone ("Special Court");

SEISED of the "Confidential Urgent Prosecution Application for Leave to Appeal Order for Service of Documents SCSL-03-01-T-451, SCSL-03-01-T-452, SCSL-03-01-T-457", filed 14 April 2008 ("Application"),<sup>1</sup> wherein the Prosecution seeks leave to appeal the "Confidential Order for Service of Documents SCSL-03-01-T-451, SCSL-03-01-T-452, SCSL-03-01-T-457" of 11 April 2008<sup>2</sup> ("Order for Service") on the grounds that:


- (i) the Trial Chamber erred when it ordered that the *ex parte* Requests for Investigation ("Requests")<sup>3</sup> be served on the Defence, and;
- (ii) the Trial Chamber erred in holding that the Defence are entitled to present arguments that the material provided by the Prosecution does not give any cause for reasonable belief that contempt might have been committed and to make other relevant submissions should it choose to do so;<sup>4</sup>


RECALLING that the *ex parte* Requests were subsequently served in accordance with the Order for Service and that the Trial Chamber has since dismissed all such Requests as being unsubstantiated;<sup>5</sup>

FINDING therefore that the issue is now moot;

DISMISSES the Application.
