PROTECTIVE MEASURES OF WITNESS TF1-215**

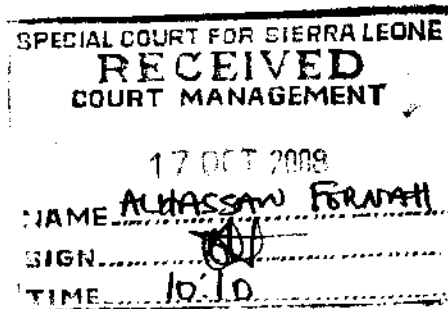

**THE APPEALS CHAMBER** of the Special Court for Sierra Leone;

**SEIZED** of the “Public With Confidential Authorities Prosecution Notice of Appeal and Submissions Regarding the Decision Concerning Protective Measures for Witness TF1-215”, filed on 23 September 2008 (“Prosecution Notice of Appeals and Submissions”), which challenged Trial Chamber II’s oral decision of 6 May 2008 that Witness TF1-215 did not have protective measures and ordering that the witness testify in open court;<sup>1</sup>

**NOTING** the Prosecution, by its “Public Prosecution Request to Withdraw Notice of Appeal and Submissions Regarding the Decision Concerning Protective Measures for Witness TF1-215”, filed 7 October 2008, request to withdraw its appeal because Witness TF1-215 has indicated that he knowingly and willingly waives protective measures and is willing to testify in open court without such measures;<sup>2</sup>

**FINDING** that the issue presented by the Prosecution in its Notice of Appeals and Submissions is now moot;

**GRANTS** the Prosecution request to withdraw its appeal, and **DISMISSES** the Prosecution Notice of Appeal and Submissions.

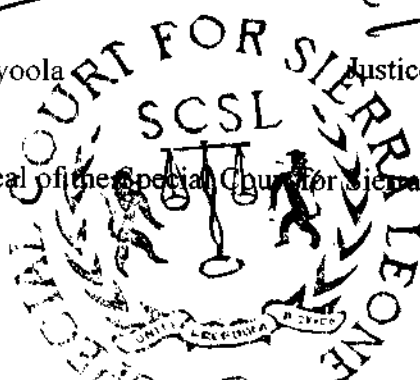
