

TRIAL CHAMBER II ("Trial Chamber") of the Special Court for Sierra Leone ("Special Court");

SEISED OF the "Public with Annex A Prosecution Request for Leave to File Supplemental Argument in Light of the Appeals Chamber Decision on 'Prosecution Notice of Appeal and Suhmissions Concerning the Decision Regarding the Tender of Documents'", filed on 10 February 2009 ("Motion"), wherein the Prosecution, in light of a recent ruling of the Appeals Chamber, seeks leave to file supplemental arguments to four Motions currently pending hefore the Trial Chamber;

CONSIDERING that it is in the interests of justice that the Trial Chamber decides the pending Motions in question as expeditiously as possible;

PURSUANT to Rules 7(C), 26bis and 54 of the Rules of Procedure and Evidence of the Special Court;

- (2) Any Prosecution Reply to the Defence Response shall be filed on or before 4.00 p.m. on Tuesday, 17 February 2009.
