

TRIAL CHAMBER I ("Trial Chamber") of the Special Court for Sierra Leone ("Special Court") composed of Hon. Justice Pierre Bouret, Presiding Judge, Hon. Justice Benjamin Mutanga Iroe, and Hon. Justice Bankole Thompson;

NOTING the Judgement delivered against Issa Hassan Sesay ("Sesay"), Morris Kallon ("Kallon") and Augustine Gbao ("Gbao") on 25 February 2009, where the Trial Chamber found Sesay and Kallon guilty on Counts 1 to 15 and 17 of the Indictment and Gbao guilty on Counts 1 to 11, 13, 14 and 15 of the same Indictment;

NOTING that Rule 100(B) of the Rules of Procedure and Evidence ("Rules") states that "when the Accused have been convicted by a Trial Chamber, the Trial Chamber *may* hear submissions of the parties at a sentencing hearing";

CONSIDERING that this is an appropriate case for the Trial Chamber to exercise its discretion pursuant to Rule 100(B) of the Rules to hear submissions of the parties at a public sentencing hearing;

MINDFUL of the Judgement filed on 2 March 2009;

MINDFUL of the Scheduling Order for Sentencing Hearing and Judgement filed on 2 March 2009;

REACALLING that a Sentencing Hearing is scheduled to be held on Monday, the 23 March 2009 at 10:00 a.m., for the additional oral arguments only;

PURSUANT to Rules 54 and 100 of the Rules;

ACCORDINGLY, THE TRIAL CHAMBER in the interest of justice and in order to ensure expediency,

CONSEQUENTIALLY ORDERS thar:

 the Office of rhe Prosecutor ("Prosecution") shall limit the length of its sentencing submissions to a time not exceeding two (2) hour;
