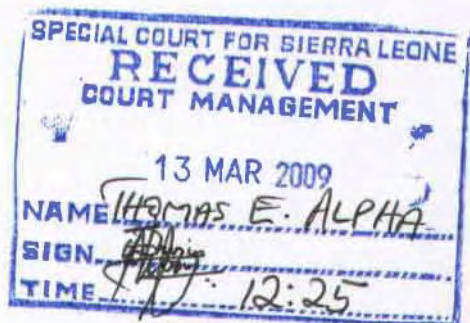

TRIAL CHAMBER I ("Trial Chamber") of the Special Court for Sierra Leone ("Special Court") composed of Hon. Justice Pierre Boutet, Presiding Judge, Hon. Justice Benjamin Mutanga Itoe, and Hon. Justice Bankole Thompson;

SITTING AS Hon. Justice Bankole Thompson, designated by Trial Chamber I pursuant to Rule 73(A) of the Rules of Procedure and Evidence ("Rules");

SEIZED OF the Sesay Application for Court Order for Re-Service of Sesay Application for Provisional Release originally filed Under Seal, filed on 12 March 2009 ("Application")¹ wherein the Sesay Defence requests that the Trial Chamber order re-service on the Parties of a prior filed Sesay Defence Motion,² the said Motion having been filed under seal;³

NOTING the Responses of the Prosecution,⁴ the Kallon Defence,⁵ and the Gbao Defence,⁶ communicated to the Trial Chamber via email, wherein no objections to the granting of the application were raised;

CONSIDERING that the document for which re-service is requested contains information that may assist the Sesay Defence in preparing its submissions in relation to sentencing;⁷

FINDING that re-service of the document under seal will not reveal any confidential information to any persons not already entitled to access such information;

PURSUANT to Rules 4, 54 and 73(A) of the Rules;


