
**NOTING** Rule 100(C) of the Rules of Procedure and Evidence ("Rules") which states that:

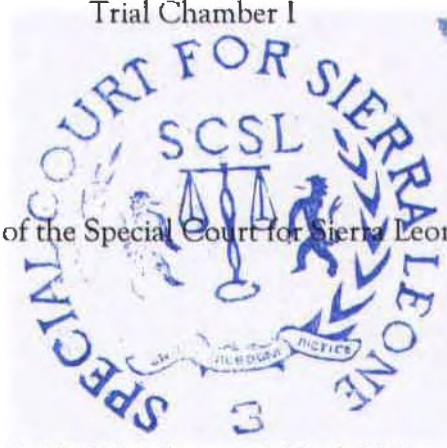
