DECISION ON CONFIDENTIAL PROSECUTION MOTION FOR LEAVE TO SUBSTITUTE A PAGE IN THE CONFIDENTIAL ANNEX B OF PROSECUTION MOTION SCSL-03-01-T-808

TRIAL CHAMBER II ("Trial Chamber") of the Special Court for Sierra Leone ("Special Court");

SEISED of the "Confidential Prosecution Motion for Leave to Substitute a Page in the Confidential Annex B of Prosecution Motion SCSL-03-1-T-808", filed on 15 July 2009 ("Motion"), wherein the Prosecution requests the Trial Chamber to order that: (i) Court Management Section ("CMS") recall page 25782 of CMS Document SCSL-03-01-T-808 ("CMS 808") from all persons who were served with a hard-copy of the document; (ii) CMS notify all persons who were served with the document in electronic format not to replicate the page 25782 of CMS 808 in any way and to delete the entire document; (iii) the Prosecution re-file page 25782 of CMS 808; and (iv) CMS re-serve the document with the amended page to all concerned parties;²

NOTING the "Defence Response to Confidential Prosecution Motion for Leave to Substitute a Page in the Confidential Annex B of Prosecution Motion SCSL-03-1-T-808", filed on 23 July 2009 ("Response"), 3 wherein the Defence states that it does not oppose the relief requested; 4

CONSIDERING that the relief requested is not opposed by the Defence;

PURSUANT to Rules 54 and 73(A) of the Rules of Procedure and Evidence;

HEREBY GRANTS the Motion; and

ORDERS that:

- (i) Court Management Section immediately recall page 25782 of CMS Document SCSL-03-01-T-808 from all persons who were served with a hard-copy of the document;
- (ii) Court Management Section immediately notify all persons who were served with the document in electronic format not to replicate page 25782 of CMS Document SCSL-03-01-T-808 in any way and to delete the entire document;
- (iii) the Prosecution re-file amended page 25782 of CMS Document SCSL-03-01-T-808; and
