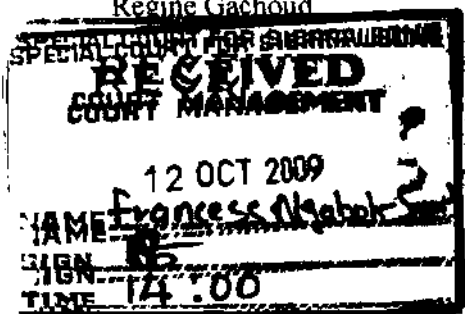

NOTING the "Sesay Defence Response to Prosecution Grounds of Appeal", "Kallon Response to Prosecution Appeal Brief", "Gbao Response to Prosecution Appellant Brief" and "Prosecution Response Brief", filed on 24 June 2009;


NOTING the "Sesay Reply to Prosecution Response to Sesay Grounds of Appeal", "Kallon Reply to Prosecution Response Brief", "Gbao Reply to Prosecution Response to Gbao Appellant Brief" and "Prosecution Reply Brief", filed on 29 June 2009;
