


HEREBY GRANTS the Prosecution request to withdraw the Motion; and

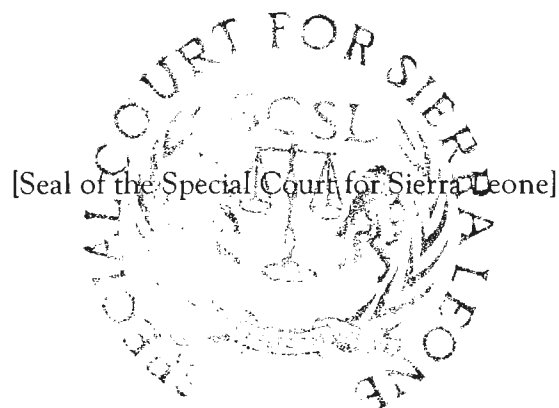
ORDERS that the Motion be withdrawn and dismissed.
