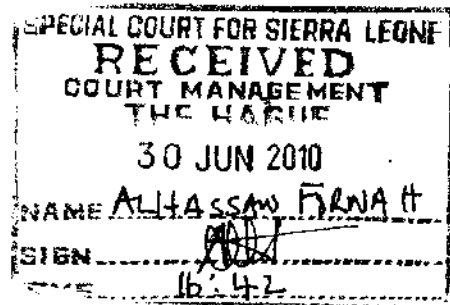

TRIAL CHAMBER II (“Trial Chamber”) of the Special Court for Sierra Leone (“Special Court”);

SEISED of the “Defence Application to Correct the Transcript of 25 June 2010”, filed on 28 June 2010 (“Motion”),<sup>1</sup> wherein pursuant to Rule 81(B) of the Rules of Procedure and Evidence (“Rules”) the Defence requests that the transcript of 25 June 2010 be corrected by replacing the words “understand from - one, from my NPFL commander called Senegalese” on page 43542, line 21, with “understand from one former NPFL commander called Senegalese” in order to ensure the preservation of a full and accurate record of the proceedings;<sup>2</sup>

NOTING the “Prosecution Response to Defence Application to Correct the Transcript of 25 June 2010”, filed on 30 June 2010 (“Response”),<sup>3</sup> wherein the Prosecution concurs with the Defence request and does not oppose the Motion;<sup>4</sup>

SATISFIED that an amendment to the transcript is justified and would ensure the preservation of a full and accurate trial record;

PURSUANT to Rule 73(A) and 81(B) of the Rules;


GRANTS THE MOTION; and


