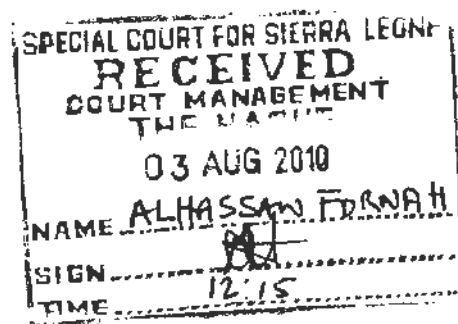

TRIAL CHAMBER II ("Trial Chamber") of the Special Court for Sierra Leone ("Special Court");

SEISED of the "Public Application for Leave to File Motion to Appear as Counsel to a Witness", filed on 2 August 2010 ("Application"),¹ wherein the legal representative of Witness Ms. Carole White seeks leave to file a motion to appear as counsel for Ms. White ("Motion");²

NOTING that Ms. White will be called as a witness in this trial³ and that her legal representative seeks leave to move the Court for permission to appear as counsel for Ms. White in her capacity as a witness;

CONSIDERING that, as Ms. White is scheduled to testify before the Trial Chamber on 9 August 2010,⁴ an expedited timetable for filings is warranted;

FOR THE ABOVE REASONS, THE TRIAL CHAMBER


GRANTS Ms. White's legal representative leave to file the Motion; and

ORDERS that:

- (1) The Motion shall be filed no later than 9:00 (Hague Time) on Wednesday, 4 August 2010;
- (2) Responses to the Motion, if any, by the Prosecution or the Defence shall be filed no later than 17:00 on Wednesday, 4 August 2010.
