PURSUANT to Rules 7(C), 26bis, and 54 of the Rules;

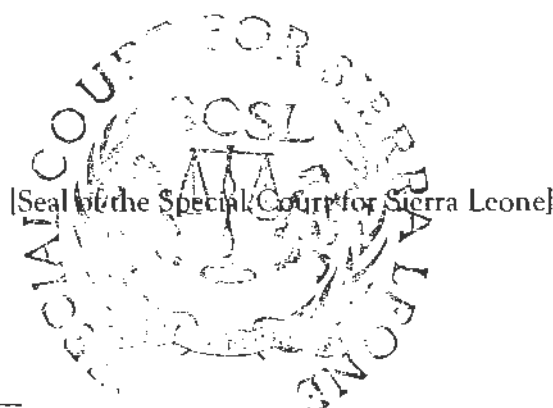
HEREBY ORDERS that:
