DECISION ON PROSECUTION CORRIGENDUM AND MOTION FOR LEAVE TO SUBSTITUTE PAGES OF THE PROSECUTION FINAL TRIAL BRIEF

**RECALLING** that the Prosecution filed its "Confidential Final Trial Brief" on 14 January 2011<sup>1</sup> as directed by the Trial Chamber in its Order of 22 October 2011;<sup>2</sup>

SEISED of the "Prosecution Corrigendum and Motion for Leave to Substitute Pages of the Prosecution Final Trial Brief", filed on 18 January 2011 ("Motion"), wherein the Prosecution seeks leave:

- (i) to amend its Final Trial Brief with the corrections set out in the chart on pp. 2-5 of the Motion;
- (ii) to substitute three pages of the Final Trial Brief attached in Annex A to correct errors made through administrative oversight;<sup>4</sup>

**NOTING** that at the status conference held on 20 January 2011, the Defence stated that it was not in a position to respond to the Motion, "not having seen the final brief or, indeed, looked at the suggested corrections", 5 and that subsequently, the Defence did not file a response to the Motion;

CONSIDERING that the Motion merely seeks to correct certain typographical errors in the text of the Prosecution Final Trial Brief and to substitute corrected pages for three pages of the brief that contain typographical errors and other minor amendments;

**PURSUANT** to Rule 73(A) of the Rules;

HEREBY GRANTS THE MOTION; and


## **ORDERS THAT:**

- (i) the Prosecution Final Trial Brief be corrected as set out in the chart on pp. 2-5 of the Motion;
- (ii) the original cover page, p. 2 and p. 30 of the Final Trial Brief be replaced by the corrected pages as set out in Annex A to the Motion.
