SCHEDULING ORDER FOR STATUS CONFERENCE ON 18 JUNE 2012

Mr. Eugene O'Sullivan Mr. Christopher Gosnell Justice Shireen Avis Fisher, Designated Judge of the Appeals Chamber of the Special Court for Sierra Leone ("Special Court"), acting in accord with the Chamber's "Order Designating A Judge Pursuant To Rule 116" dated 7 June 2012;

NOTING the "Defence Motion for Extension of Time to File Notice of Appeal" ("Defence Motion") filed on 5 June 2012, wherein the Defence requests an extension of the deadline for the filing of its Notice of Appeal by 5 weeks until 19 July 2012;

NOTING the "Prosecution Response to Defence Motion for Extension of Time to File Notice of Appeal" filed on 6 June 2012 ("Prosecution Response") in which the Prosecution does not oppose a 3 week extension of the deadline for the Parties to file their respective Notices of Appeal by 5 July 2012;

RECALLING that according to the timeframe set out in Rule 108 (A) of the Rules of Procedure and Evidence of the Special Court ("Rules"), Notices of Appeal are to be filed within 14 days from the date of receipt of the full judgment and sentence (31 May 2012), requiring filing to be completed on or before 14 June 2012;

RECALLING that the time limits set out in Part VII of the Rules may be extended upon a showing of good cause, according to Rule 116;

CONSIDERING that a Status Conference would be the most expeditious way in which to hear further submissions of the parties on this matter as well as on other matters relevant to the timing of potential filings under Rules 111, 112, and 113;

CONSIDERING FURTHER that for logistical reasons, the earliest time to schedule a Status Conference is after 14 June 2012;

PURSUANT to Rules 65bis and 106(C) of the Rules;

ORDERS that a Status Conference shall be held on Monday, 18 January at 10:30 A.M and that the following agenda items shall be addressed at the Status Conference:

- i. The Defence Motion and Prosecutor's Response;
- ii. Any further extension requests anticipated by the Parties for the completion of subsequent filings specified in Rules 111, 112, and 113.

FURTHER ORDERS that the deadline for filing of Notices of Appeal, pursuant to Rule 108(A), is stayed until further Order of the Court.
