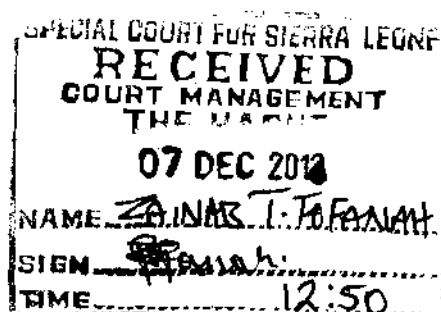

The Appeals Chamber of the Special Court for Sierra Leone (“Special Court”)

BEING SEISED of the “Urgent Defence Motion to Reclassify Part of Public Annex I to Its Rule 115 Motion as Confidential”¹ (“Urgent Defence Motion”) filed on 6 December 2012;

CONSIDERING that Figure 1 appended to Public Annex I of the Defence Rule 115 Motion² reveals the email addresses of two court staff members, as well as the telephone numbers of one of them;

NOTING Article 4(B) of the Practice Direction³;

HEREBY ORDERS as follows:

- 1) Defence Counsel shall redact the relevant contact details contained in Figure 1 appended to Public Annex I of its Rule 115 Motion;
- 2) Defence Counsel shall refile the relevant page as amended;
- 3) Court Management Section of the Special Court (“CMS”) shall recall all distributed copies of the Rule 115 Motion from all persons who were served a hard copy of the said Rule 115 Motion and re-circulate to them a redacted version of the page in question;
- 4) CMS shall notify all persons who were served with the Rule 115 Motion in electronic format to not replicate the relevant page of Annex I in unredacted form;
- 5) The redacted version of the Rule 115 Motion shall be treated as authoritative.
