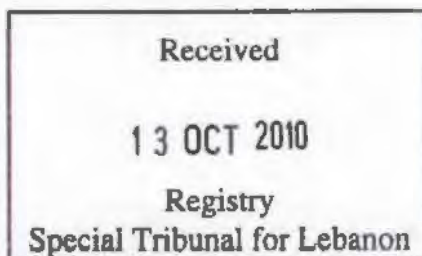

**I, ANTONIO CASSESE, President** of the Special Tribunal for Lebanon (“Tribunal”);

**NOTING** the “Appeal of the ‘Order Relating to the Jurisdiction of the Tribunal to Rule on the Application by Mr El Sayed Dated 17 March 2010 and Whether Mr El Sayed Has Standing before the Tribunal’ and Urgent Request for Suspensive Effect” by the Tribunal’s Prosecutor and subsequent filings in the case;

**RECALLING** the Scheduling Order issued by me on 1 October 2010 in this matter;<sup>1</sup>

**NOTING** that Article 8(1) of the Statute of the Tribunal (“Statute”) provides that five judges shall serve on the Tribunal’s Appeals Chamber (“Appeals Chamber”);

**NOTING** Article 17 of the Annex to UN Security Council resolution 1757 (2007), providing that “Judges of the Trial Chamber and the Appeals Chamber shall take office on a date to be determined by the Secretary-General in consultation with the President of the Special Tribunal. Pending such a determination, judges of both Chambers shall be convened on an ad hoc basis to deal with organizational matters and serving, when required, to perform their duties”;

**NOTING** the letters issued by the Secretary-General of the United Nations on 12 February 2009, appointing five Judges to the Appeals Chamber effective 1 March 2009;

**CONSIDERING** the need for the Appeals Chamber to convene in order to carry out its judicial function;

**NOTING** the Letter of the UN Legal Counsel dated 30 September 2010 advising that the UN does not have any objection to disclosing the names of the Appeal judges if all necessary security measures are put in place;
