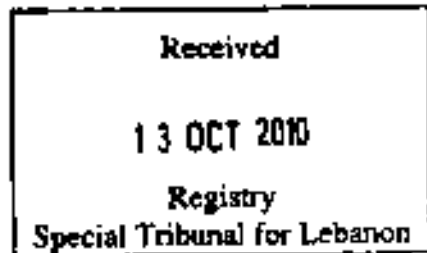

ORDER REFERRING MATTER TO THE APPEALS CHAMBER

I, **ANTONIO CASSESE**, **President** of the Special Tribunal for Lebanon (“Tribunal”);

NOTING the “Recours contre le deux décisions du Président: (1) suspendre l’Ordonnance du juge de la mise en état (2) inviter les nations Unies comme *amici curiae*” (“*Recours*”), filed by Mr El Sayed on 11 October 2010;

RECALLING the Scheduling Order issued by me on 1 October 2010 in this matter;¹

RECALLING the Order on Composition of the Appeals Chamber issued by me today;²

NOTING that Article 8(1) of the Statute of the Tribunal provides that five judges shall serve on the Tribunal’s Appeals Chamber;

NOTING Article 17 of the Annex to UN Security Council resolution 1757 (2007), providing that “Judges of the Trial Chamber and the Appeals Chamber shall take office on a date to be determined by the Secretary-General in consultation with the President of the Special Tribunal. Pending such a determination, judges of both Chambers shall be convened on an ad hoc basis to deal with organizational matters and serving, when required, to perform their duties”;

NOTING that the Appeals Chamber will convene in November 2010 to deal with the matters raised by the “Appeal of the ‘Order Relating to the Jurisdiction of the Tribunal to Rule on the Application by Mr El Sayed Dated 17 March 2010 and Whether Mr El Sayed Has Standing before the Tribunal’ and Urgent Request for Suspensive Effect” by the Tribunal’s Prosecutor and subsequent filings in the case;

CONSIDERING the need to hear from both parties on the matter;

PURSUANT TO Rule 32(B),
