



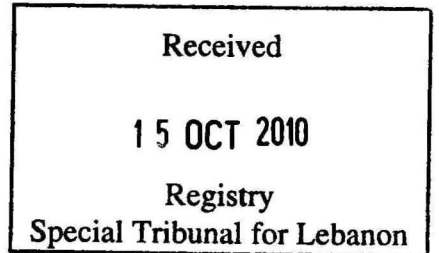

I, Antonio Cassese, PRESIDENT of the Special Tribunal for Lebanon (“Tribunal”);

NOTING the “Order relating to the jurisdiction of the Tribunal to rule on the application by Mr El Sayed dated 17 March 2010 and whether Mr El Sayed has standing before the Tribunal” (“Order of 17 September 2010”) issued by the Pre-Trial Judge on 17 September 2010;

NOTING the “Appeal of the ‘Order Relating to the Jurisdiction of the Tribunal to Rule on the Application by Mr El Sayed Dated 17 March 2010 and Whether Mr El Sayed Has Standing before the Tribunal’ and Urgent Request for Suspensive Effect” (“Appeal”) by the Tribunal’s Prosecutor (“Prosecutor”) and the “Information sur le dépôt par le Requéérant le 30 septembre 2010 d’une opposition à la demande du Procureur d’une mesure urgente et demande d’information sur l’identité des juges qui composent la cour d’appel” by Mr El Sayed, both filed on 29 September 2010;

RECALLING the Scheduling Order issued by me on 1 October 2010;

NOTING the Amicus Curiae Brief filed on the same date by the United Nations Under-Secretary-General for Legal Affairs (“Amicus Curiae Brief”) on the inviolability of United Nations documents;

CONSIDERING the need for a more comprehensive discussion of the issues arising from the Amicus Curiae Brief, including the question of whether this is a matter to be decided during the instant appellate proceedings;

CONSIDERING therefore that it is appropriate to extend the deadline for observations to be filed by the parties;
