**NOTING** Rule 86 (A) of the Rules of Procedure and Evidence according to which, after an indictment has been confirmed, a person claiming to be a victim of a crime within the jurisdiction of the Special Tribunal for Lebanon may request the Pre-Trial Judge to be granted the status of victim participating in the proceedings;

**NOTING** Rule 89 (B) of the Rules entitled "Functions after Review of the Indictment", according to which "the Pre-Trial Judge shall ensure that the proceedings are not unduly delayed" and to that end allow him to take "any measures necessary to prepare the case for a fair and expeditious trial";

**NOTING** the counts mentioned in the Indictment of 10 June 2011 in the case concerning the attack against Rafiq Hariri, confirmed by the Pre-Trial Judge on 28 June 2011 (the "Indictment");

CONSIDERING that in order to ensure that the proceedings are not unduly delayed in accordance with Rule 89 (B) of the Rules, the Pre-Trial Judge finds it necessary that a deadline be set for filing all applications (to be granted the status of victim participating in the proceedings) from those persons claiming to be victims of the offences mentioned in the Indictment;

CONSIDERING that the scheduling of this deadline is intended to enhance the fairness of the proceedings by allowing those persons granted the status of victim participating in the proceedings in accordance with the aforementioned Rule 86 (A) to express their "views and concerns", pursuant to Article 17 of the Statute and to the relevant provisions of the Rules, during the initial pre-trial phase of the case;

CONSIDERING that the scheduling of such a deadline is likewise aimed at increasing the efficiency and expeditiousness of the proceedings and is conducive to the proper administration of justice in that it gives the Pre-Trial Judge a comprehensive view of the applications that will be filed before ruling on them;

**ORDERS** the Registrar to take all necessary measures to ensure that this Order is disseminated to the persons concerned, by such means as he deems appropriate.


