1. NOTING the Order making public certain Prosecutor's submission in the

Ayyash et al Case of 8 February 2012 (the "Order");

2. **CONSIDERING** that there are two clerical errors in the Order:

a) Paragraph 13 of the Order refers to "Annex B of the Prosecutor's Addendum of

25 January 2012" instead of referring to "Annex C of the Prosecutor's Addendum of

b) Paragraph 14 of the Order refers to "Annex C of the Prosecutor's Addendum of

25 January 2012" instead of referring to "Annex B of the Prosecutor's Addendum of

25 January 2012";

FOR THESE REASONS,

THE PRE-TRIAL JUDGE,

ORDERS that Paragraph 13 of the Order now reads as follows:

"CONSIDERING that the redactions proposed by the Prosecutor in Annex C of the

Prosecutor's Addendum of 25 January 2012 are necessary to protect the effective conduct of

the investigation or the persons concerned by those documents, with the exception of the

proposed redaction of the Prosecutor's signature, given, in particular, that it has previously

been rendered public and that no valid reason has been advanced to justify that it should be

redacted;"

ORDERS that Paragraph 14 of the Order now reads as follows:

"CONSIDERING that, in relation to the additional redactions proposed by VWU in

Annex B of the Prosecutor's Addendum of 25 January 2012, the Pre-Trial Judge is not

convinced that these proposals are necessary to protect the relevant persons and to address all
