- The Trial Chamber has scheduled a hearing for 13 June 2012 to hear argument on motions challenging the jurisdiction of the Tribunal, filed by the Defence of the four Accused, Salim Jamil Ayyash, Mustafa Amine Badreddine, Hussein Hassan Oneissi and Assad Hassan Sabra.¹
- 2. Defence counsel for the four Accused wrote to the Trial Chamber on 30 May 2012 asking it to schedule extra time for the hearing on 14 June 2012 to, among other things, permit them to have "the last word to formally reply". The Prosecutor objected, in a confidential filing, to both the substance and form of the request. The Trial Chamber does not accept that any Party has an inherent right to a "last word" in a hearing restricted to legal argument, but will allow time for argument on 14 June 2012.
- 3. The four motions challenging jurisdiction repeat many similar legal arguments. The Trial Chamber reminds the Parties and participants of two things. First, the purpose of this hearing is to allow them to develop their arguments, respond to the opposing submissions and answer questions from the bench. Second, the Trial Chamber will have read all the submissions and observations well before the hearing. In the interests of judicial economy, the Trial Chamber therefore encourages Defence counsel to co-ordinate their oral arguments and avoid repeating the same legal submissions. The Trial Chamber has thus allocated a block of time, on 13 June, for all Defence submissions and leaves it to Defence counsel to decide among themselves how to use it.

10:30 to 11:00	Responses by Defence counsel
11:15 to 11:45	Responses by the Prosecutor
11:45 to 12:00	Responses by legal representative for participating victims

5. The Trial Chamber also orders the lifting of the confidentiality of the Prosecution's application of 1 June 2012 and orders counsel for the Defence to file their letter, dated 30 May 2012, with the Tribunal's Court Management Services Section.
