Report:

1. Coordination of the exchanges between the parties:

- In accordance with Rule 110 (A) (i) and the Orders of 24 January 2012 and 7 February 2012, the Prosecution stated that it had disclosed to the Defence all the supporting materials, some in their entirety, and some in redacted form, with the exception of the documents which are the subject of a request seeking disclosure of a summary in their stead.
- The Pre-Trial Judge encouraged the Parties to cooperate and continue the management of the disclosure of the supporting materials directly between them.

2. Preliminary motions:

 The Pre-Trial Judge set the deadline for the filing of preliminary motions challenging jurisdiction for 4 May 2012, while pointing out that the filing date for other preliminary motions would be set later

3. Producing a work plan:

- The Prosecution stated that it did not intend to file the brief prior to the trial proceedings while it has not decided on the possible amendment of the Indictment.
- Counsel for the Defence indicated that they were not able at the present time to estimate the
 amount of time they would need to prepare their defence. In this respect, they referred to a
 number of difficulties linked in particular to the nature of the materials disclosed, and to requests
 for cooperation made to States.
- The Pre-Trial Judge set the schedule regarding victims' participation in the proceedings as follows:
 - o the general decision on the status of victims participating in the proceedings will be rendered within the month; and
 - the decision on the modalities of the victims' participation will be rendered following the above decision.
