- 1. By way of this Order, the Pre-Trial Judge decides on the Duty Legal Representative's request for leave to file a reply (the "Request for Leave") to the Registrar's Submissions in response to the Motion for Review of the Registrar's Designation of the Lead Legal Representative of Victims Participating in the Proceedings (the "Submissions").²
- 2. On 13 August 2012, the Duty Legal Representative for Victims V027 and V028 filed a Motion for Review of the Registrar's Designation of the Lead Legal Representative (the "Motion for Review").³
- 3. On 15 August 2012, the Pre-Trial Judge notified the Registrar of the Motion for Review and invited him to respond thereto.⁴ Subsequently, the Registrar filed the Submissions on 21 August 2012.
- 4. Pursuant to Rule 8 of the Rules of Procedure and Evidence (the "Rules"), the Duty Legal Representative filed the Request for Leave to reply to the Registrar's Submissions on 24 August 2012. He avers that the Submissions make "certain assertions of law and fact that warrant specific refutation," and that it would therefore be in the interest of justice that he be allowed to file a reply.⁵
- 5. The Pre-Trial Judge notes that this matter concerns *inter alia* the standard of review of an administrative decision of the Registrar designating a victim's legal representative. The review of an administrative decision of the Registrar in general, and of his designation of a victim's legal representative in particular, is without precedent before this Tribunal. The Pre-Trial Judge therefore considers that the arguments put forward by the parties should be briefed in full. Being mindful of the exceptional circumstances of the current case, the Pre-Trial Judge grants the Duty Legal Representative to file his reply to the Registrar's Submissions of 21 August 2012.

THE PRE-TRIAL JUDGE,


PURSUANT TO Rules 8 and 9(A)(i) of the Rules,
