- 1. Defence Counsel for Salım Jamil Ayyash, Mustafa Amine Badreddine, Hussein Hassan Oneissi, and Assad Hassan Sabra have seized the Appeals Chamber of appeals against the Trial Chamber's 11 July 2012 "Decision on Reconsideration of the Trial In Absentia Decision".
