- 1. In my Second Interim Decision, I suggested that the Head of Defence Office and the Registrar enter into further discussions on how to best resolve their dispute with regard to the employment of Dr Omar Nashabe as an investigator assisting the Defence teams. I also invited them, as well as Defence Counsel and the Prosecutor, to make further written submissions by today on the merits of the dispute; the confidentiality of the decision; whether Dr Nashabe should be given access to it; and whether he should be permitted to file submissions in relation to the allegations made against him.<sup>2</sup>
- 2. In a joint filing, the Head of Defence Office and the Registrar have informed me that their discussions are continuing, and they request an extension of time until 21 September 2012, 4 pm, to make submissions on the merits of the dispute and on the participation of Dr Nashabe.<sup>3</sup> In order to facilitate these talks, I vary the schedule included in the Second Interim Decision and order that such submissions should be filed by that date and time.
- 3. In the light of the submissions requesting that the Second Interim Decision should remain confidential during the discussions between the Head of Defence and the Registrar, <sup>4</sup> I order that the decision should provisionally retain confidential status until further notice. However, as indicated in my Second Interim Decision, I require the showing of good cause why and, if so, to what extent this decision should remain confidential. <sup>5</sup> I accordingly reserve final judgment on this matter.
